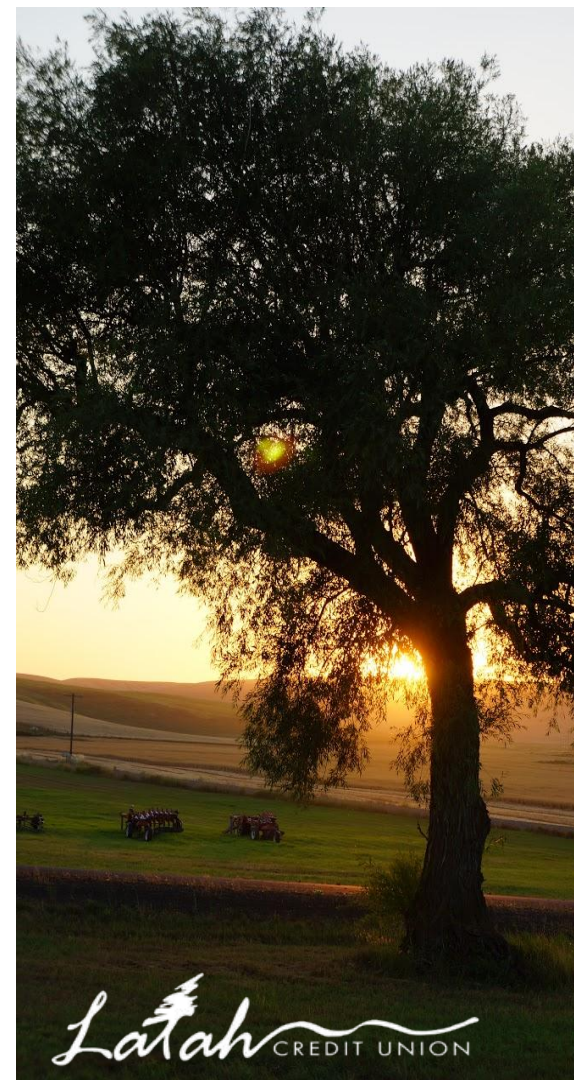

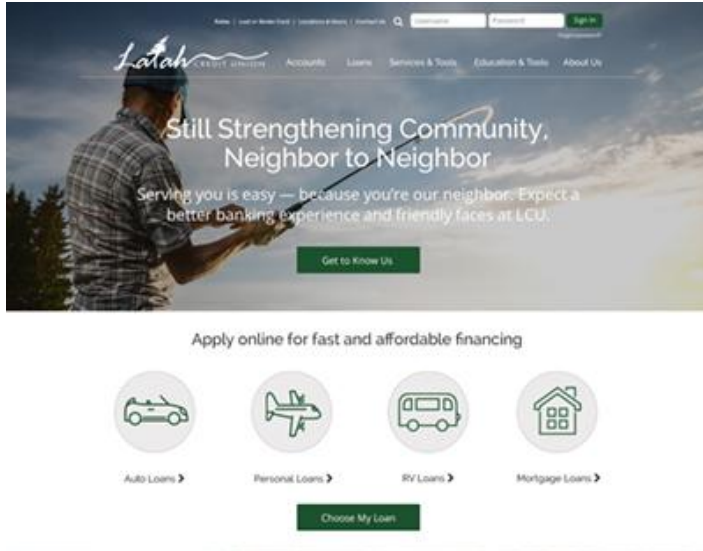

Provide text alternatives for non-text content

Provide captions and audio descriptions

Allow text to be resized up to 200%

Allow users to adjust time limits on viewing pages

Make all functionality available from a keyboard
